TABLE OF FEES 2017/18

The fees set out below apply where the person to be interred was immediately before his or her death a parishioner of the City of Ely. In the case of a stillborn child, the parents must be resident of the Parish. In all other cases, the fees will be **doubled**. The body of a non-parishioner will not be accepted unless the Exclusive Right to Burial, to the grave in question had been purchased at an earlier date. Fees for this will be double.

The Exclusive Right to Burial in Ely Cemetery must be acquired at the time of interment and cannot be pre purchased. For an existing grave ownership must be confirmed as either being the recently deceased, or be a living relative who is named on the Exclusive Right to Burial Document. If this is not the case then the ownership must be transferred prior to the interment taking place.

Please ensure payment is made to the Council at least 3 clear working days prior to the interment.

A charge of £18.00 inclusive of VAT will be made for any incorrect or late payments.

PART 1 INTERMENT *(including digging of the grave)*

Funerals after 2.30pm from Monday to Thursday and after 2pm on a Friday will be considered on a case by case basis and charges for such funerals will be advised accordingly.

Depending on individual circumstances additional charges may be made. If a grave requires hand digging then the fee will be doubled

For any interment in a grave:

a)	Of the body of a still-born child	No charge
b)	Of the body of any other child aged 14 years or under	No charge
c)	Of the body of person in a double depth grave	£430.00
d)	Of the body of a person in single depth grave	£375.00
e)	Interment of ashes	£104.00
f)	Interment of ashes with the interment of a coffin	£39.00
g)	Additional charge for interments taking place on or after 2pm (only accepted in exceptional circumstances)	£152.00
h)	Use of Cemetery Chapel	£82.00

PART 2 EXCLUSIVE RIGHTS TO BURIAL

Not exceeding 99 years in the first instance in an earthen grave. To be purchased at the time of interment unless already previously purchased.

a)	Grave – 9 feet x 4 feet	£203.00
b)	Grave – 3 feet x 2 feet	£86.00
c)	Transfer of Exclusive Right to Burial including one new copy	£41.00
d)	Assignment of Exclusive Right to Burial or addition of names	£21.00
e)	Additional copies of transferred Exclusive Right to Burial	£6.00
f)	Search for copy of Exclusive Right to Burial	£18.00

PART 3 SEARCHES

Fees for searches of register books and for copies to be taken

a)	Every search covering a period of not more than 1 year	£23.00
b)	Every additional year	£6.00
c)	Every certified copy of an entry of burial in the register books	£18.00

PART 4 MONUMENTS AND MONUMENTAL INSCRIPTIONS*(Where the Exclusive Right to Burial has been purchased)**The following fees include the first inscription on the memorial**All memorials require written approval prior to installation*

a)	Not exceeding 2 feet in height and 1 foot in width	£106.00
b)	Not exceeding 4 feet in height	£168.00
c)	Desk top memorial	£106.00
d)	Subsequent inscriptions after the first	£57.00
e)	Like for like replacement of a memorial	£57.00
