2. DECLARATION OF INTERESTS AND REQUESTS FOR COUNCILLOR DISPENSATIONS:

5. INFORMATION ONLY ITEMS:

(i) Decision Notices – Approvals

17 Broad Street, Ely – Proposed alterations to the windows, doors and an increase in the ridge height of the flat roof section.

Alameda, 29b Cambridge Road, Ely – T1 Oak – Reduce canopy by 2.5m on garden side and west over neighbouring property. Crown raise by an additional 1m.

T2 Lime – Reduce crown by 2.5m and remove epicormic growth to second main fork.

5 The Oakery, Lynn Road, Ely – To comply with Condition 5 (Tree Topping, Lopping & Felling) of Decision Notice 03/08/1973.

Ely Museum, Market Street, Ely – The addition of 2no high level projecting aluminium signs to the listed building, 3no. Al aluminium poster cases to replace the existing poster cases on the southern courtyard wall and 2no. aluminium signage panels to either side of the entrance gate into the Museum courtyard.

- 67 Beresford Road, Ely Revised scheme of previously approved 20/00112/FUL Extension to front above existing single storey extension including a sun tube.
- 97 Downham Road, Ely Variation of Condition 1 (Approved plan) and Condition 3 (materials) of previously approved 19/00469/FUL for demolition of existing redundant outbuildings. New single storey extension and minor internal modifications.
- 2 Barton Square, Ely Bin store, retrospective.
- 24 Henley Way, Ely To comply with Condition 10 (Tree Topping, Lopping & Felling) of Decision Notice 89/00679/OUT.
- 2 Clayway, Ely To comply with Condition 5 (Tree Topping, Lopping & Felling) of Decision Notice 98/00833/OUT. Alexander House, 38 Forehill, Ely To vary Condition 1 of previously approved 19/00121/FUL for conversion of under-croft to the existing building to create 1no. ground floor apartment and a roof extension to create 4no. apartments within the roof, together with bike and bin storage provision and associated external works including the recladding of the existing building.
- 20 Broad Street, Ely Proposed loft conversion.

20/01124/FUL - 20 Broad Street, Ely – Proposed loft conversion. Amendment involves a change from pitched to flat roof dormer.

20/00222/FUL – Nyton Hotel, 7 Barton Road, Ely – Demolition of existing extension on east side of property, erection of function room and bar seating area to south of property and construction of 3 new 2-bedroom holiday homes to the north of the site with onsite parking, access and associated works. Amendment to the orientation of the proposed holiday lets.

20/01072/FUL – Proposed erection of a detached 2-bedroom, 2-storey house with associated parking and landscaping. Amendment to door case on front door.

Sindalthorpe House, Mile End Road, Prickwillow, Ely – Replacement to two existing garage buildings with one new building.
