MINUTES OF A MEETING OF THE CITY OF ELY COUNCIL HELD IN THE COUNCIL CHAMBER AT 7.00 PM ON MONDAY, 10TH JANUARY 2011

1. APOLOGIES

Apologies were received from Cllr Chaplin.

2. REQUEST INTENTION OF THOSE IN ATTENDANCE WHO WISH TO SPEAK ON AN AGENDA ITEM – as per standing order 60 b

3. MINUTES OF THE LAST MEETING & MATTERS ARISING

The minutes of the last meeting held on the 6th December were agreed and signed as a true record, following the correction in item 3, minutes of the last meeting held on the 8th November and minute page number 1012 should have read 1102. Pages 1103, 1104, 1105 and 1106 refer.

Matters arising:- Page 1103, Item 3 – The Mayor gave a further update on CCTV. Cllr Burton was undertaking the CCTV training course with 11 other people. The transfer of the administration responsibilities from ECDC was still outstanding.

Page 1104, Item 7 – The Mayor confirmed a response had been received from the County Council regarding the Pavement Permit Policy. This has been passed to the Street Furniture Committee to progress and arrange a meeting with the County Council.

Page 1104, Item 8 – The Mayor informed members there would be an Extraordinary Meeting of the Council on the 17th January to set the precept for 2011/2012.

Page 1105, Item 10 – The Clerk informed members there had been no response from the County Council following the comments made regarding tenders for contracted bus services – proposed changes for April 2011.

Page 1105, Item 11 – The Mayor updated members on the progress of Ely Riverside.

Page 1105, Item 12 – The Mayor and Cllr Bradney had both spoken to Giles Hughes at ECDC. It was anticipated that a seminar could be organised at the end of February. Soham Town Council will also be invited to attend. A letter will be sent to Mrs Dawe, Chairman of Stuntney Village Council updating her on how we are progressing with this issue.

Page 1106, Item 17 – Cllr Yates informed members he had been unable to organise a meeting of local organisations before Christmas, but a date for this meeting will be arranged shortly. Tracey Harding from ECDC had also expressed an interest in attending this.

4. QUESTION TIME

District Cllr J Friend-Smith informed members that work was now complete at Thistle Corner. The Section 38 Agreement between the developers and the County Council still needed to be signed. Once this had been undertaken the roundabout should then be able to open.

He had raised his concerns again with ECDC regarding the buffer zone near Alexander Chase and Collier Close. Section 106 money could be used to help progress the problems with linking these developments up.

Cllr Rouse raised his concerns that the streetlights at Tesco and the garage were not working. A new streetlighting contract is now in place and work has been undertaken in Ely over the last week. If these are still not working the Clerk will report them to the County Council.
