MINUTES OF A MEETING OF THE CITY OF ELY COUNCIL HELD IN THE COUNCIL CHAMBER AT 7.00 PM ON MONDAY 11TH MARCH 2013

1. APOLOGIES

Apologies were received from Cllr Chaplin.

2. REQUEST INTENTION OF THOSE IN ATTENDANCE WHO WISH TO SPEAK ON AN AGENDA ITEM – as per standing order 83 b

Mr Coney, District Cllr Hunt and District Cllr Bailey declared their intention to speak on agenda item 4.

3. MINUTES OF THE LAST MEETING HELD ON THE 11TH FEBRUARY & MATTERS ARISING

The minutes of the last meeting held on the 11th February were agreed, and signed as a true record, with the correction of 'has' to 'had' in item 13. Pages 1241, 1242, 1243, 1244 and 1245 refer.

Matters arising – Page 1244, Item 15 – Cllr Eden informed members of the death of Mr Kevin Hall, CCC Highways Officer. Members unanimously agreed this was a great loss. It was agreed the Mayor would send a personal card to his widow. Cllr Yates reported that he had attended the funeral last week.

4. QUESTION TIME

District Cllr A Bailey said she was delighted with the news today, that East Cambs District Council and the City of Ely Council, had decided to drop the proposal to introduce car parking charges in Ely's car parks. She felt this was a testament to people power. She gave a summary of the headline results from the public consultation with regard to the proposed car parking charges. She asked that the City of Ely Council work with ECDC to actively promote Ely's car parking to the whole country; encourage ECDC to look again at its business rates relief policy, to support new businesses to Ely's centre and to encourage ECDC to make better and more imaginative use of its current enforcement resources and to address the issues for resident's parking.

Mr Ted Coney said that the news about car parking charges was a victory for common sense. He felt that as the City of Ely Council was always proactive in promoting and looking after Ely, perhaps they could help the District Council with this. He requested free car parking be promoted as a selling point for the City. He also gave several ideas for promoting Ely.

District Cllr Bill Hunt said he was delighted with the withdrawal of the proposed car parking charges. He asked the Council to support a campaign to change the signs in the car parks, which would encourage people to spend time in Ely and visit businesses. He was also glad the Council had recommended refusal for the amendments for the Croylands planning application.

The Mayor thanked everyone for their statements and confirmed that any suggestions made would be referred back to the appropriate Committees/Working Groups for consideration.

District Cllrs Hunt and Bailey, Mr Coney, Mr Olley and the two other parishioners left the meeting at 7.20 pm.

8. COMMITTEE REPORTS

- (i) ADMINISTRATION The Mayor presented a report of a meeting held on the 25th February, which was approved. The updates on the Maltings Cottage, the Court House and the members' seminar were noted. The Internal Auditor's report from the visit on the 13th November was noted. A Council drop-in stall will be held on the 18th May at the Saturday market. A small working group, consisting of Cllrs Every, Yates and Eden had been formed to review the Council's forms of communication. The Clerk tabled a report of the annual review undertaken by herself, the Mayor and Deputy Mayor of the Council's adopted Policies and Procedures. Cllr Yates proposed the Council approve the review and recommended amendments. This was seconded by Cllr Eden and unanimously approved by members. The Mayor signed all the reviewed policies and procedures.
- (ii) STREET FURNITURE Cllr Griffin-Singh presented a report of a meeting held on the 26th February, which had been tabled. This was approved. Five new dog bins, which have been purchased by the City Council will be installed by ECDC. Members unanimously approved the quote of £975.96 for a recycled plastic notice board for Prickwillow. This will be funded through Section 106. Members noted the request for two new bus shelters to be installed on King's Avenue. Further details regarding design and costs will be obtained and discussed further at the next Street Furniture Committee meeting.
- (iii)RECREATION & CEMETERY No report as Committee had not met. There will be a tour for the members of the cemetery in April.
- (iv) CHRISTMAS LIGHTS No report as Committee had not met. The next meeting will be on the 18th March.
- (v) ELY IN BLOOM No report as Committee had not met. The next meeting will be held on the 19th March.
- (vi) ELY/RIBE Not met.
- (vii)YOUTH FORUM Cllr Yates informed members a meeting had taken place last week, where the Youth Fair was reviewed. It was agreed to hold two further Youth Fairs, one before the summer holidays and one after. The Youth Fair had been a great success, with 250 names and organisations now on the Youth Forum database.

9. WORKING PARTIES/STEERING GROUPS REPORTS

CCTV Partnership Steering Group - Cllr Every reported the next meeting will be held on the 9th April. The review panel have met and produced a draft report regarding the review of the CCTV system. On-Street Car Parking Review Working Group – a meeting will be arranged shortly.

10. REPORTS FROM EXTERNAL MEETINGS

Section 106 meeting – minutes of a meeting held on the 25th February were noted. Members unanimously approved the recommendations to fund new footpaths at Ely Cemetery; upgrade to fencing and equipment at St John's Road Recreation area and hard standing for two bus shelters for King's Avenue. Members also agreed to support Ely City Football Club's request for a contribution towards floodlights for the Football Club. City of Ely Allotments Association – minutes of a meeting held on the 8th January were noted. City of Ely Perspective Design Group – minutes of a meeting held on the 15th January were noted. City of Ely Perspective Riverside Group – minutes of a meeting held on the 12th February were noted. Cllr Rouse informed members of the Play Area Review recently completed by ECDC. The Clerk will forward this to members when it is received from ECDC.

11. UPDATE ON ELY COURT HOUSE

The Mayor had produced a discussion document on the way forward for Ely Court House. This will be discussed at the next Localism Working Group meeting. The Mayor will arrange a visit to Ely Court House for members, for next week. The Mayor informed members he would be calling an Extraordinary meeting on the 25th March for the Council to make a formal decision on whether they wish to take ownership of Ely Court House, as this needs to be decided before the end of March.

12. UPDATE ON THE MALTINGS COTTAGE

The Mayor informed members a first draft of the working drawings for the Maltings Cottage had been received.

13. SHAPE YOUR PLACE CURRENT ISSUES

Members considered a response from Cambs County Council regarding a request for a mini roundabout on Downham Road and West Fen Road, via Shape Your Place. Members felt that this was not an appropriate place for a mini roundabout. It was agreed to suggest to the Highways Department that a mirror be installed on this junction, to allow cars turning right into West Fen Road to see cars coming from St Mary's Street. It will also be suggested that the path could be widened to push traffic out to make them more visible to cars turning. There are no lines painted down the middle of the road, and it was agreed that if these were present, it might improve the problems in this area.
