## (i) Decision Notices – Approvals

- 24 New Barns Road Single storey rear extension, replacement front wall/railing and steel pergola, with glass roof to rear.
- 35 St Mary's Street, Ely Removal of 2 x external spiral staircases, addition of new window in flank wall, addition of roof light, alteration of escape doors to windows and other window alterations; replacement of vehicular and pedestrian gates; removal of 2 trees and hedge in rear garden; pruning of Highways tree in front garden.

The Homestead, 14 Egremont Street, Ely – Installation of iron railings to front of house.

- 9 Barton Road, Ely Demolition of side extension and alterations to property, including site frontage
