1. APOLOGIES:

Apologies were received from Cllr Pittock.

2. DECLARATION OF INTERESTS AND REQUESTS FOR COUNCILLOR DISPENSATIONS

Cllrs Every and Hobbs declared an interest as ECDC Councillors in Plans T and U, and signed the Register of Members Interest Book, pages 138 and 137 respectively. They left the room whilst these plans were being discussed. Cllr A Whelan and Cllr C Whelan also declared an interest in Plan U and also signed the Register of Members Interest Book, pages 139 and 140 respectively. They also left the meeting when this was discussed. There were no requests for councillor dispensations.

4. PLANS SUBMITTED BY EAST CAMBS D C:
