#### 5. INFORMATION ONLY ITEMS

# (i) Decision Notices – Approvals

- 2 Pilgrims Way, Ely Extension of existing property over two floors to create small spa at ground floor and additional bedrooms at first floor.
- 31-33 Lynn Road, Ely Two storey extension of kitchen and bathroom to rear elevation of property. Division of property into two separate two-bedroom houses. Demolition of outbuilding and construction of new outbuildings.
- 29 Henley Way, Ely Construction of single storey rear extension which extends beyond the rear wall by 4.3m, has a maximum height of 4m and an eaves height of 2.8m. (permission is not required).
- 62 St John's Road, Ely Construction of single storey rear extension which extends beyond the rear wall by 4.5m, has a maximum height of 2.8m and an eaves height of 2.45m. (permission is not required.)

### (ii) Decision Notices - Refusals

- 13 Forehill, Ely Demolition of single storey derelict brick outhouse, single storey outside toilet block, and 2-storey brick and concrete extension to rear of shop. Construction of 3 storey extension to rear of shop with 2 new residential units at first and second floor; existing first floor residential unit maintained with some alterations.
- 13 Longfields, Ely Change of use of land from landscaping to garden use & retrospective application for erection of 1.8m close board fence (retrospective).

# (iii) Certificate of Lawfulness of existing use or development.

Castle Lodge Hotel, 50 New Barns Road, Ely – Creation of two rooms from one and three further ground floor rooms.
