(i) Decision Notices – Approvals

21 Broad Street, Ely – Installation of new external ducting system to rear of building.

Wings Hostel, Station Drove, Shippea Hill – To vary condition 1 (Time Period) of previously approved 11/00165/FUL for erection of a refurbished 9 bay modular unit (9.6m x 27m) for use as welfare facilities, change of use of existing amenity units to dormitory accommodation (Retrospective).

67 Downham Road, Ely – To vary condition 1 (Approved Plans) and 3 (materials) of previously approved 14/01214/FUL for proposed dwelling, integral double garage, parking & associated site works.
