#### 1. APOLOGIES

#### 4. MINUTES OF THE LAST MEETING HELD ON THE 3RD APRIL 2017 AND MATTERS ARISING

The Chairman thanked all the members of the Council for the support they had given him during his Mayoral year. ### 6. QUESTION TIME

Cllr Rouse, in his capacity as a County Councillor, informed members that as there had been two objections to the proposed double yellow lines at Dovehouse Close, this had to be considered formally by councillors. The officer's recommendation to allow this, was approved. The lines will be installed shortly.

#### 11. COMMITTEE REPORTS

- (i) PERSONNEL, FINANCE AND GOVERNANCE No report as Committee had not met. However, members noted the superannuation contribution rates set for the next three years. 2017/18 33.4%, 2018/19 35.1%, 2019/20 36.8%. Cllr Hobbs raised the issue of the Mayor's allowance and how this should be administered. After a lengthy discussion, it was agreed to appoint a Working Group of Cllrs Yates, Friend-Smith and Lansell to review this allowance and make a recommendation to the next Personnel, Finance and Governance Committee.
- (ii) ENVIRONMENT –Cllr Lansell presented a report of a meeting held on the 10th April, which was approved. The QGIS map software had now been installed and operator training had now taken place. A new dog bin had been installed on the corner of The Hamlet and Lynn Road in Chettisham. It is also planned to install a new bin in Compton Fields as soon as possible. Cllr Lansell informed members he now felt it was impractical to install more bollards along the High Street. A new City of Ely Flag would be purchased. A successful litter pick had taken place on the 2nd April. Cllr Lansell felt that these should be undertaken more frequently and that the Council should have an anti-litter campaign. He will look at this further and ascertain if there are any funds available to assist in this. Cllr Arnold gave an update on Ely in Bloom.
