174 Beresford Road, Ely – Erect conservatory to rear of property.

Land rear of 75 & 77 Deacons Lane, Ely – Proposed residential development for 8 dwellings.

10 Pasture Grove, Ely – Single storey rear extension.

Land at High Flyer Farm, North of Kings Avenue, Ely – Reserved matters for Access, Appearance, Landscaping, Layout and Scale for the Spine Road and Thistle Corner Junction of residential development 11/01077/ESO.
