1. APOLOGIES

Apologies were received and accepted from Cllr C Phillips.

2. COUNCILLOR REQUESTS FOR DISPENSATIONS

4. MINUTES OF THE LAST MEETING HELD ON THE 29TH APRIL 2019 AND MATTERS ARISING AND MINUTES OF THE ANNUAL COUNCIL MEETING HELD ON THE 13TH MAY 2019 AND MATTERS ARISING

5. CHAIRMAN'S ANNOUNCEMENTS

The Chairman welcomed everyone to the first full meeting of the new Council. He welcomed members elected for the first time; Councillors Arnie Arnold, Sarah Bellow, Edward Carlsson Browne, Rebecca Denness, Matt Downey, Richard Morgan and Kevin Wilkins.

He said the election had resulted in the loss of the Mayor Elect, Alison Arnold and he paid tribute to all her hard work and how personally sorry he was that she did not get the well-deserved opportunity to serve as Mayor. He also wanted to place on record the Council's appreciation of the enormous contribution that former Cllr Richard Hobbs, four times Mayor of the City, had made to the work of the Council over many years. Ever ready to take on responsibilities, Richard Hobbs was a selfless servant of the City and along with his wife Pat, tireless in his efforts to improve Ely and the lives of the people living in the parish.

He thanked members for having the confidence in him, to re-elect him as their Mayor and Chairman for a further year. He appreciated the honour and the responsibility that the post entails and will do his utmost to serve everyone's best interests.

5. CHAIRMAN'S ANNOUNCEMENTS CONTINUED

He congratulated Cllr Sue Austen for being elected as Deputy Mayor and looked forward to working with her. He also congratulated her on becoming Vice-Chairman of the District Council.

He also congratulated Cllr Lis Every on being elected Vice-Chairman of the County Council and Chairman of East Cambs District Council.

He repeated some words from this time last year:

'He hoped we will be able to work together, to support each other as we face the challenges of the year. The strength of this Council, and it can be seen as a weakness at times, is that all decisions are taken in a Committee structure where each vote has the same value. He thought the Council could improve upon the Committee structure, giving members more responsibility, which is why these are currently being reviewed and he thought the Council could bring in even more transparency to some of the things that it does. He hoped that while he was in the Chair, there would be a fair and open debate and hoped that decisions are reached that the Council could all agreed upon, or if not, that the majority view will then be supported and can move forward as a Council.'

He told members that this was their Council and he wanted to concentrate on the role of Mayor and less on the day to day business of the Council. He asked them to play as full a role as they were able to, in order to achieve the things that they wanted. He reminded them however, that the budget was already set for this year. He suggested they plan to get things into next year's budget, but if it was urgent then the Committee should be asked to be a little bit imaginative and try and find the money, by perhaps re-prioritising the work.

On a point of etiquette or procedure he believed members were elected to speak for the whole City and parish, but if there were ward specific issues and it was not their ward, then out of courtesy he requested they discuss it with the representatives from that ward.

6. QUESTION TIME

A parishioner, asked if the Council had made any progress with the speaker system for the Council Chamber. The Clerk informed them that quotes had been obtained for a company and at the next Full Council meeting this system will be trialled to see if it meets the Council's requirements. If it is successful, then two further quotes will need to be obtained.

She also raised how disappointing it was that there had been an incidence of hate speech on social media locally. Cllr Every reported that through the County's Communities and Partnership Committee they work on community resilience and one of their priorities is working on the Hate agenda, across Cambridgeshire and Peterborough. One strand of which, is to manage changes to ensure easier access for reporting and recording. She agreed to report to Full Council, on a regular basis with regard to this issue.

Annual Meeting of the County Council

At the Annual Meeting of the County Council, Cllr Lis Every was elected as Vice-Chairman of Council. Cllr Anna Bailey was confirmed to continue in her role as Chairman of the Adults Committee.

Information about the Combined Authority Staffing Structure and Additional Income

The current staff budget at the Combined Authority is £4.4m. Since the original devolution deal, the Combined Authority has taken on three large new responsibilities:

- 1) The Local Enterprise Partnership (LEP) which is the body that receives infrastructure funding from central Government and puts money into things like Ely Bypass. This organisation now comes under the Combined Authority and comes with its own staffing structure and additional money to pay for those staff
- 2) The Energy Hub
- 3) Adult Education

All the extra responsibilities require extra staffing and extra money to pay for those staff has been provided by central Government - £1.8m in total. It is worth noting that the Cambridgeshire & Peterborough Combined Authority has the least staff of any of the Mayoral Combined Authorities.

The original devolution deal brought in £770m into Cambridgeshire and Peterborough. Since the devolution deal was agreed the Combined Authority has levered in an additional £347m, so a total of £1.117b of new money into the county.

Eight Car Trains between Cambridge and Kings Lynn

The Combined Authority has been lobbying Government for improvements in passenger capacity on the Kings Lynn to London line. In early February the Mayor, James Palmer met with the Rail Minister and it was announced shortly afterwards that the necessary work will be done to extend the platforms to accommodate eight car trains with work beginning in October this year.

CAM Metro

The Combined Authority agreed funding to progress to the next stage of investigations for this very significant new public transport scheme, which includes tunnelling under Cambridge.

Cambridge South Railway Station and Soham Railway Station

The Combined Authority also agreed funding to consider an 'interim solution' for a new station at Cambridge South (Addenbrooke's). Practical work on the new Railway Station in Soham has now begun with noise testing being carried out on site.

A10 Upgrade and A142 / A10 & Lancaster Way Roundabouts

The Combined Authority Board authorised commissioning the Strategic Outline Business Case stage for the A10 dualling project which also includes a package of other transport measures, including junction upgrades, an off route cycle path from Ely to Cambridge and relocation of Waterbeach Railway Station.

Shorter term, Anna continues to work on the A142 / A10 "BP" and Lancaster Way roundabouts which are in her patch, and sits on the Project Group at the County Council. Investigation work has been carried out regarding the location of services at the key points, as there is concern about the location of a high pressure gas main in particular, which would have serious cost implications. Early indications are positive!

Adult Skills in East Cambs

The Combined Authority and the County Council are working together to significantly change the offer for adults skills and learning which are set to hugely benefit East Cambridgeshire residents. The new service proposes a much more flexible approach to build courses and sessions around the needs of local residents and individuals. The intention is to have a permanent base, with locations being sought in Ely, and the ability for pop up sessions and courses of learning being made available in areas of identified need, which could include Soham and Littleport. Anna and Lis are working with staff to bring this to the District.

Pot Holes & Highways Maintenance

The County Council continues to make good progress with keeping up to date on dealing with potholes, and Members will have noticed a lot of carriageway full resurfacing, carriageway dressing work and recycling treatment taking place across East Cambs as well as the completion of the drought damaged road schemes.

Investment into Libraries

The County Council is investing in its library network, with new libraries planned for new communities and upgrading of existing libraries. Locally, Soham Library is undergoing extensive refurbishment to create a new welcoming, flexible and accessible library space to support the delivery of local services to the community from the library, such as Neighbourhood Cares, which helps people find the support they need locally to help them live independently.

There is also a very exciting new programme to redesign the way libraries in Cambridgeshire could look in the future.

The proposed 'Cambridgeshire Model', developed in partnership with global social enterprise Civic, offers a unique opportunity for the County Council to help boldly re-imagine and re-design the UK's 3,000 libraries, piloting it in Cambridgeshire and Peterborough.

The 54 libraries across Cambridgeshire span the diversity of some of the most deprived rural communities in the country, the vibrancy and opportunity offered through our major urban centres and market towns, through to the 40,000 new homes planned in brand new towns. This unique network of physical spaces across a huge breadth of community settings, coupled with the Council's ambition to ensure our libraries are at the heart of the community, is an ideal test bed for new ideas and to develop blueprints for libraries that are replicable and scalable across the UK and beyond.

The proposed process is to develop five models of 'Libraries of the Future' that reflect the diversity of communities and contexts around the UK. The idea is that each library within Cambridgeshire and Peterborough will be a close fit to one of the models, making it simple and cost-effective to replicate across the region and ultimately, the country.

The five models are:

- Anchor to the High Street
- · Centre for Rural Life
- (Re)Animating Communities
- · Hub for the Region

Pop-Up for Reviving Community Assets

Move from Shire Hall

The Council has agreed on a preferred bidder, Brookgate, for the lease of the Shire Hall campus, as part of its move to a hub and spoke model, which aims to get the workforce based out into the communities they serve as well as releasing a significant new income stream to the Council from the Shire Hall site. The lease is likely to significantly exceed the financial expectations of the original business case and means the site will remain in public ownership. This also confirms the County Council's requirement to enshrine continued public access to the Castle Mound and Civil War Earthworks.

Plastics Strategy

The Council's General Purposes Committee agreed minor changes to the Council's new Plastics Strategy which came about as a result of Anna's motion to Full Council and will now go back to Full Council for final sign off.

The Strategy aims to systematically reduce single use plastics both within the Council, but also across the county. The strategy looks to tackle the impacts of plastic products procured as part of its wide range of services and seek to influence our supply chain and the broader community and includes the following four themes:

- Getting our own house in order
 Actions to address the Council's internal use of single-use plastic
- Working with suppliers and contractors
 As a Council, we can influence the supply chain provision of goods and services through setting standards on plastics via procurement
- Helping raise awareness across Cambridgeshire
 The Council is a member of various partnerships, putting us in a unique position to use these relationships to influence and encourage action on plastic waste
- Enabling Cambridgeshire to take action
 As a Waste Disposal Authority, the Council works closely with Waste Collection Authorities to enable households to manage their waste sustainably.

Stuntney Cycle Path

Options for the agreed Stuntney to Ely cycle path improvements are being worked up and we will ensure the Village Council is consulted.

The Corporate Parenting Sub-committee which monitors the work undertaken on behalf of our 760+ children in care is focusing on the statutory Local Offer for those leaving care at 18 (until 25) covering the strands of: accommodation; education, training and employment; health and well-being; finances; relationships and participation in society. At the young people's request, we are working with them on the major issues of mental health and health generally. Following a recent review, the work of the Virtual School which looks after young people in care's education to the age of 18 has been revised and a new Head will be appointed at the end of June.

The Communities and Partnership Committee works on community resilience and one of its priorities is working on the Hate agenda across Cambridgeshire and Peterborough, one strand of which is to manage changes to ensure easier access for reporting and recording. Centres have been identified for each district. The Lighthouse in Ely is one of the first centres for this area. As Community Champion, current emphasis is being placed on the ECDC Youth Strategy, social prescribing and adult skills provision. The C and P Committee works closely with the Community Safety Partnerships in each district.
