# 4. MINUTES OF THE LAST MEETING HELD ON THE 16TH DECEMBER 2019 AND MATTERS ARISING

# 5. TO RECEIVE PRESENTATION FROM PERRI LUPARIA, TRUST MANAGER FOR CAMBRIDGESHIRE POLICE SHRIEVALTY TRUST

Ms Luparia explained what the Police Shrievalty Trust was and in particular that the Cambridgeshire Bobby Scheme was a crime reduction programme, with its work overcoming the shock of crime and to help restore self-confidence, health and wellbeing. They currently receive £50,000 from the Police and Crime Commissioner and £14,000 per year is spent on supporting elderly and domestic abuse victims. In Ely last year, 36 elderly victims, 6 domestic victims and 7 children were supported under this Scheme. As there was a shortfall of funding she asked if the Council would be able to provide any financial support to them. The Clerk explained how the Council's grant process worked and agreed to send her the information. Cllr Every suggested she contact the East Cambs Safety Partnership. The Mayor thanked Ms Luparia for attending the meeting.

#### 7. OUESTION TIME

Three parishioners from the Waterside Residents Association addressed members and asked two questions. One was regarding the perilous state of the pavements in the area and asked that the Council takes the initiative in pursuing the relevant bodies responsible for these as a priority in 2020. The second was that they were also concerned about the increase in heavy vehicle traffic in the area and that this is causing damage to some properties. They requested the Council seek to extend the existing 20 mph restriction at Willow Walk to incorporate Waterside, Quayside, Ship Lane, Back Lane and Annesdale in order to secure the safety and security for the future of this vitally important historic area of Ely.

Cllr Every asked if the Group had logged their concerns on the Cambs County Council website with regard to the pavements. They confirmed this had been undertaken, but had not had a response.

The second question could possibly be considered by the Environment Committee under the Minor Highways Improvement Scheme for 2021/2022. Cllr Every agreed to meet with the Group to discuss both questions and help them move these forwards. The Mayor thanked the parishioners for bringing these issues to the Council.

### 8. REPORTS FROM COUNTY COUNCILLORS AND DISTRICT COUNCILLORS

A report from County Councillor A Bailey, who had given apologies as she had been unable to attend the meeting, was tabled and noted and is attached to these minutes.

Cllr Every informed members the planning application for the new community centre in Broad Street had been approved at the recent ECDC's Planning Committee meeting. She thanked the City Council for their support of this application. She also informed members the Bus Review Strategy and Cycling Strategy will be coming through shortly. There will be questionnaires regarding cycling, buses and walking, which will be received by every household in the district. This will be a six week consultation.

Cllr Phillips also thanked councillors for their support with regard to the community centre.

(iii) RECREATION & CEMETERY – No report as Committee had not met. The next meeting will be held on the 20th January. Cllr Phillips informed members that due to the adopted Climate Change motion, the Committee will be looking at how this can impact the cemetery and requested any ideas from members or that they attend the meeting to give their suggestions. Following agreement to extend the lease of the Willow Walk play area with Trinity Dole to 25 years, with approved Section 106 funds and three quotes having been obtained, he proposed the first stage should move forward this month, at a cost of £19,621 plus VAT. The second stage would then follow at a cost of £14,853 plus VAT. This was seconded by Cllr Warman and unanimously approved.

# Cambridgeshire County Council Update - City of Ely Council 13<sup>th</sup> January 2020

# Happy New Year to everyone at the City of Ely Council!

#### **New Premises**

Cambridgeshire County Council's new Alconbury Weald HQ building is set to open in spring 2021. An event to mark the first spade in the ground on site was held on 16 December where Councillors and contractors celebrated the start on site of a building which aims to deliver environmental excellence — as well as unlocking in excess of £45m to spend on local services.

#### **Climate Change and Environment Strategy and Action Plan**

#### **Air Quality Motion**

A motion was put forward by Steve Count, Leader, at the Full Council meeting in December which recognised the need to tackle air quality and called for this to be done in ways that would encourage behaviour rather than penalise. ### **Success for Cambridgeshire at National Social Work Awards**

Success for Cambridgeshire just kept on coming at the national Social Work Awards event in London recently! County Council employees Ella Waughman and Dan Grimes won Newly Qualified Adult Social Worker of the Year and Newly Qualified Children's Social Worker of the Year respectively. A student at Anglia Ruskin, Mary Carter, also won Student Social Worker of the Year. It is great to see Cambridgeshire getting such good coverage for its social work staff.

#### Early Intervention and Prevention Services in Adult Social Care

The Council is putting its early intervention and prevention services out to tender with the aim of moving us to a more place based, flexible approach, building on the work of Neighbourhood Cares, the Adults Positive Challenge programme, and the new community asset based approach of Think Communities. The new framework will allow communities to pull down services based on local needs and will also incorporate the Community Navigators scheme - an integral part of early intervention services will be to link people with other services already available in the community. The Council is proud of the fact that it has been able to continue to invest in services that help people to maintain their independence and enable thousands of people to continue living safely and happily at home.

#### **Adult Social Care Charging Policy**

The Adults Committee is due to consider the outcome of a consultation on changes to the way contributions to adult social care packages are charged for at its meeting on 16<sup>th</sup> January. Similar proposals were considered and rejected just over two years ago by the Committee. A number of recommendations are proposed that, if adopted, will bring the Council into line with neighbouring and other local authorities with social care responsibilities.

Thousands of people in Cambridgeshire currently arrange and pay for their care and support with no involvement from the Council, but of those in receipt of Council arranged care services, over 60% contribute from their own finances towards the cost of their care. This contributes significantly to the Council's Adult Social Care budget, and helps the Council to meet its statutory care obligations within very tight financial margins. It also enables the Council to invest in prevention and early help

services to support people to live in the community and avoid or delay the need for a more expensive care package.

In common with all Councils with social services responsibilities, Cambridgeshire has in recent years faced growing and acute financial, demographic and demand pressures in Adult Social Care - including the impacts of an increasingly ageing population and significant financial volatility in the care provider market and it is in this context that the recommendations will be considered.

### **Stronger for Longer - Falls Prevention Programme**

Falls are one of the most common causes of accidental injury in older people and the commonest cause of accidental death in the population aged 75 and over in the UK. The estimated cost of falls and fractures to the health and social care system in Cambridgeshire and Peterborough in 2017 was £85.5M. One in three people aged over 65 will fall every year, increasing to one in two people aged over 80. A fall may cause feelings of distress, injury, loss of confidence and loss of independence, which may well cause anxiety for relatives and carers. However, research shows that group and home-based exercise programmes, such as strength and balance activities, can reduce the rate of falls by approximately 30 per cent.

Cambridgeshire County Council launched the 'Stay Stronger for Longer' campaign to improve strength and balance and keep people doing the things they enjoy. The Stronger for Longer campaign has helped increase attendances to strength and balance classes by an impressive 23 per cent, with an extra 170 extra people attending over 2600 strength and balance sessions over the last year. As well as increasing the number of attendances to classes, over 24,000 people took the online 'strength and balance challenge' and over 40,000 people received the super six leaflet.
