### 5. INFORMATION ONLY ITEMS

#### (i) Decision Notices – Approvals

Central Hall, 54 Market Street, Ely – To vary condition 1 (Approved Plans) of previously approved 18/01520/FUL for proposed conversion of former NHS facility (D1) at first floor level into 3 self-contained studio flats (C3).

Garage block adjacent to 5 Willow Walk, Ely – Construction of 1no four-bedroom dwelling.

1 West End, Ely – Replace existing front elevation roof tiles, replacement windows throughout, kitchen door and patio doors

46b St Mary's Street, Ely – Replace 11m x 3m north side of the peg-tile roof with Spanish slate, addition of 12 1m x 1.65m photovoltaic panels and replace two fixed skylights 1.25m wide by up to 3m with three double-glazed hinged rooflights approximately 86cm wide x 2m high sized to fit the openings.

P Smith & Sons, 27 Newnham Street, Ely – Change of use and internal and external alterations to form 3 no. dwellings. (and Listed Building Consent).

34 Broad Street, Ely – Demolition of existing building and construction of new community centre and flat.

# (ii) Appeals

Appeal allowed and permission granted – 103 Columbine Road, Ely – Loft conversion.

### (iii) Amendments

19/00269/FUL – 34 Broad Street, Ely – Demolition of existing building and construction of new community centre and flat. The amendment involves a change to rear elevation to show external staircase.

19/01249/FUL – Site south west of Church Farm, The Hamlet, Chettisham, Ely – Demolition of existing farm buildings and construction of 4 bed dwelling – the amendment involves the removal of gates.
