4	Budget Update and to Consider First Draft of the Budget for 2022/23	To receive a budget update and to consider the first draft of the budget for 2022/23	Councillors noted the budget updated for the period up to the 31st October 2021. The Clerk had amended the figures with regard to the business rates for all properties and tabled a revised budget. This was proposing a precept for 2022/23 of £660,000, which would result in a 3.43% increase on a band D council tax property. This increase would be below the current rate of inflation. Councillor Rouse proposed the budget for 2022/23 be recommended for approval at the next Full Council meeting and a precept of £660,000 be set. This was seconded by Cllr Ganivet and unanimously approved.	Full Council
