Cllr A Whelan raised her concerns regarding the amount of money being spent on the Maltings and OCH and asked how the Council could justify putting up the council tax for that reason. She felt the people of Ely should be asked if they are happy to pay for these services. The Clerk did confirm that when the budget was set for this year that it was agreed that once the Council moves into the next financial year there will be a review of the services that the Council offers and public consultation will be undertaken, if felt necessary with regards to these and the cost implications of them.
